The BCWCA Bergen County Championship Individual/Team Golf Tournament is scheduled for **Wednesday, May 8<sup>th</sup> 2019** with a rain date of Wednesday, May 15th. Tee off will be promptly at 7:30 AM using **the Overpeck county course** in Teaneck. The tournament will be open to all N.J.S.I.A.A. High School Girls in Bergen County. Eligibility rules of the N.J.S.I.A.A. will be used for the tournament. In order to best serve all girls, there will be two tournaments going on at the same time.

1. Medal (stroke) play for 18 holes with awards to the top 3 individuals.
2. Team play is 18 holes.
  - a. Each school is allowed to play 5 golfers and count the best 4 to determine the winners. Awards to the top three teams.
  - b. Double par will be in effect indicated by an x placed instead of a numerical score.
  - c. The number of double par will be used to break ties.

All participants must have a coach present.

**All golfers should be signed in by 7:15 AM so that we can get a group picture and make a few remarks.**

The individual tournament will feature a shot-gun start and the girls will be grouped based on the rankings obtained from their season's adjusted scores.

Please make sure all the golfers have appropriate attire and an adequate supply of tees and golf balls.
